# Special Consumers Fireworks Discharge Guide Sheet

#### Why do I need a Special Fireworks Discharge Permit?

All persons wishing to use fireworks on dates OTHER than December 31 from 10:00 a.m. until January 1 at 12:30 a.m.

July 4 from 10:00 a.m. until 12:30 a.m.

July 3 and July 5 from 10:00 a.m. to 11:00 p.m.

Must obtain a permit from Campbellsville Fire Department and meet guidelines as established by:

Kentucky State Law- KRS Chapter 227 & City of Campbellsville Ordinance 21-02

#### What is the cost of the Special Consumer Fireworks Discharge Permit?

There are No fees for the permit or inspection.

#### How can I get a Special Permit to discharge fireworks?

- Call Campbellsville Fire Department Administration at (270) 465-4131 between the hours of 8:00 a.m. and 4:00 p.m. Monday through Friday. Application can be delivered and filled out at time of inspection by Campbellsville Fire Department.

#### What are the requirements to receive a Special Permit?

Permit requirements established by: Kentucky State Law- KRS Chapter 227 & City of Campbellsville Ordinance 21-02

- Proposed site must be inspected and approved by Campbellsville Fire Dept.
- Permits issued for up to 4 hour period from noon 10:00 pm
- Fireworks shall not be discharged on property of another without written consent.
- Proposed site must provide for required clearances, Fireworks shall not be ignited within 200 feet of any structure, vehicle or other person. KRS 227.715(11)(b)
- Fireworks shall not be discharged on public property, including roadways.
- Submittal of application required 15 days prior to proposed use.
- Discharge only of Consumer fireworks as defined by KRS 227.702 (1), (2) and (3).
- Consumer fireworks as defined by KRS 227.702 (2) and (3) may only be used by individuals at least 18 years of age.
- Permit will be revoked if there is failure to comply with the provisions of this permit, City Ordinances or State Laws

Permit will be issued only after inspection and approval of Campbellsville Fire Dept. \*There is NO FEE for permit or inspection

Permit requirements established by: Kentucky State Law- KRS Chapter 227 & Campbellsville City Ordinance 21-02.

- SHALL NOT BE IGNITED WITHIN 200 FEET OF ANY STRUCTURE, VEHICLE OR OTHER PERSON
- SHALL NOT BE DISCHARGED ON PROPERTY OF ANOTHER WITHOUT WRITTEN CONSENT
- SHALL NOT BE DISCHARGED ON PUBLIC PROPERTY, INCLUDING PUBLIC ROADWAYS. Unless exempted by conditions noted in a city permit
- SUBMITTAL OF APPLICATION REQUIRED FIFTEEN DAYS PRIOR TO PROPOSED USE
- DISCHARGE ONLY OF CONSUMER FIREWORKS AS DEFINED BY KRS 227.702 (1),(2) and (3) .
- CONSUMER FIREWORKS AS DEFINED BY KRS 227.702 (2) and (3) MAY ONLY BE USED BY INDIVIDUALS AT LEAST 18 YEARS OF AGE
- PERMIT WILL BE REVOKED IF THERE IS FAILURE TO COMPLY WITH PROVISIONS OF THIS PERMIT AND CITY ORDINANCES
- PERMIT DOCUMENT IS TO BE ON-SITE DURING FIREWORKS DISCHARGE

IMPORTANT: It is the responsibility of the applicant to ensure that any persons using or igniting the consumer fireworks authorized by this discharge permit is compliant with City ordinance and state law.

The applicant agrees that the applicant and all other persons discharging consumer fireworks authorized by this discharge permit shall follow all laws, rules, regulations and conditions imposed by the Commonwealth of Kentucky and the City of Campbellsville. The applicant and other persons discharging consumer fireworks shall solely be responsible for any and all damages caused by the discharging of the consumer fireworks. The applicant acknowledges and agrees that the City of Campbellsville shall not be responsible for any such damages and the applicant agrees to indemnify and hold the City, its officials, officers, agents and employees harmless from any claims that may ever be asserted arising from the discharge of consumer fireworks pursuant to this permit. The applicant further acknowledges and agrees that the approval of this discharge permit shall not be construed to create a co-partnership or joint venture by and between the City and the applicant or make the City, ifs officials, officers, agents or employees responsible in any way for any losses or damages caused by the actions of the applicant or other persons discharging consumer fireworks authorized by this discharge permit.
